

CHIEF VINTAGE STURGIS, SD EDITION PURCHASE OPPORTUNITY

TERMS & CONDITIONS: AUSTRALIA & NEW ZEALAND

1. Promoter

The Promoter of the Chief Vintage Sturgis, SD Edition Purchase Opportunity ("Promotion") is Indian Motorcycle Australia Pty Ltd and Indian Motorcycle New Zealand Ltd ("Promoter").

2. Promotion Overview

The Promotion provides eligible entrants with the opportunity to be selected to purchase one (1) of five (5) Chief Vintage Sturgis, SD Edition motorcycles allocated across Australia and New Zealand.

This Promotion is not a giveaway, raffle, lottery or competition to win a motorcycle.

No motorcycle will be awarded free of charge.

Selected entrants will receive only the opportunity to purchase a Chief Vintage Sturgis, SD Edition motorcycle, subject to these Terms and Conditions.

Submission of an entry does not guarantee selection, allocation, availability or the right to purchase a motorcycle.

3. Motorcycle Allocation

A total of five (5) Chief Vintage Sturgis, SD Edition motorcycles have been allocated for distribution across Australia and New Zealand.

The Promoter reserves the right to determine the final allocation of motorcycles between countries, dealerships and selected entrants.

The availability of the motorcycle is limited and no additional motorcycles are guaranteed to become available.

4. Eligibility

To enter, an entrant must:

- Be a current Indian Motorcycle Rider (IMR) member at both the time of entry and the time of selection.
- Be at least 18 years of age.
- Be a legal resident of Australia or New Zealand.
- Hold a valid motorcycle licence in their country of residence.

- Be legally eligible to purchase, register and own a motorcycle.

Employees, contractors, dealers, distributors, agencies associated with the Promoter and members of their immediate families are not eligible to enter.

The Promoter reserves the right to verify an entrant's eligibility at any time.

5. Promotion Period

The Promotion opens at **12:01am AEST on 9 August 2026** and closes at **11:59pm AEST on 30 September 2026** ("Promotion Period").

Entries received outside the Promotion Period will not be considered.

6. How to Enter

During the Promotion Period, eligible entrants must complete and submit the official entry form through the designated Promotion platform.

Only one (1) entry per eligible IMR member is permitted.

Multiple entries from the same individual may result in disqualification.

No purchase is required to enter.

Incomplete, illegible, misleading or fraudulent entries may be deemed invalid at the Promoter's discretion.

7. Selection Process

Following the close of the Promotion Period, the Promoter will review all eligible entries and select five (5) entrants.

Selection is expected to occur on or around **7 October 2026**.

The Promoter may establish and maintain a reserve list of eligible entrants in the event a selected entrant declines or fails to complete the purchase process.

The Promoter's decision is final and binding.

No correspondence regarding selection decisions will be entered into.

8. Notification of Selected Entrants

Selected entrants will be contacted using the phone number, email address or other contact details provided with their entry.

If a selected entrant cannot be contacted after reasonable attempts, the Promoter reserves the right to withdraw the opportunity and offer it to another eligible entrant.

9. Opportunity to Purchase

Each selected entrant will receive the opportunity to purchase one (1) Chief Vintage Sturgis, SD Edition motorcycle.

The opportunity to purchase:

- Is personal to the selected entrant.
- Cannot be transferred, sold, assigned or gifted.
- Cannot be exchanged for cash.
- Cannot be exchanged for another motorcycle model.
- Is limited to one (1) motorcycle per selected entrant.

Selection does not create ownership rights in the motorcycle.

Ownership will only pass upon completion of a valid purchase transaction through an authorised Indian Motorcycle dealership.

10. Purchase Conditions

To secure their allocation, a selected entrant must:

- Accept the purchase opportunity within seven (7) days of notification.
- Complete all required purchase documentation.
- Meet all dealership purchase requirements.
- Pay the applicable retail purchase price.
- Pay all applicable taxes, registration fees, dealer delivery costs and any other associated charges.

The final transaction will be conducted through a participating authorised Indian Motorcycle dealership nominated by the Promoter.

Failure to meet these requirements may result in forfeiture of the purchase opportunity.

Availability of Vehicle

The opportunity granted under this Promotion is an opportunity to purchase a Chief Vintage Sturgis, SD Edition motorcycle if and when the motorcycle becomes available for retail delivery in Australia or New Zealand.

The Promoter does not represent or warrant that the motorcycle will be available for delivery by a particular date.

In the event production, importation or allocation of the model is reduced, delayed or cancelled, the Promoter's liability is limited to refunding any deposit or purchase monies paid by the selected entrant in accordance with applicable law.

11. Failure to Proceed

If a selected entrant:

- Declines the purchase opportunity;
- Does not respond within the required timeframe;
- Fails to maintain IMR membership;
- Is determined to be ineligible;
- Provides false or misleading information; or
- Fails to complete the purchase process,

the Promoter may withdraw the opportunity and offer it to another eligible entrant.

12. Resale Restriction

The Promotion is intended to reward genuine members of the Indian Motorcycle community.

The Promoter reserves the right to refuse, withdraw or cancel a purchase opportunity where it reasonably believes an entrant:

- Entered on behalf of another person;
- Entered for the primary purpose of commercial resale;
- Is acting as a broker, reseller or intermediary; or
- Has otherwise sought to circumvent the intent of the Promotion.

13. Production, Delivery and Availability

The Chief Vintage Sturgis, SD Edition is a limited-production motorcycle manufactured in limited quantities for selected global markets.

Selected entrants acknowledge and agree that:

- The motorcycle may not be available for immediate delivery following selection.

- Delivery is anticipated to occur no earlier than December 2026 and may extend into January 2027 or later.
- Delivery timing is an estimate only and may change due to manufacturing, shipping, customs clearance, regulatory approvals, supply chain disruptions or other circumstances beyond the Promoter's control.
- The Promoter does not guarantee any specific delivery date.
- Delays in production, importation, allocation, shipping or delivery will not entitle a selected entrant to compensation, reimbursement or any alternative benefit.
- The Promoter reserves the right to amend production schedules, delivery timing and allocation quantities where reasonably necessary.

The selected entrant's purchase rights remain subject to the ultimate availability of the motorcycle from the manufacturer.

14. No Guarantee of Future Access

Submission of an entry does not guarantee:

- Selection;
- Allocation of a motorcycle;
- Access to future inventory;
- Future purchase opportunities; or
- The availability of additional Chief Vintage Sturgis, SD Edition motorcycles.

Only five (5) motorcycles are allocated to Australia and New Zealand under this Promotion.

15. Entrant Conduct

The Promoter reserves the right to reject or disqualify any entrant who:

- Breaches these Terms and Conditions;
- Provides misleading information;
- Tampers with the entry process;
- Acts fraudulently or dishonestly; or

- Engages in conduct that may damage the reputation of the Promoter or Indian Motorcycle brand.

16. Privacy

By entering, entrants consent to the Promoter collecting, storing and using their personal information for the purposes of:

- Administering the Promotion;
- Verifying eligibility;
- Contacting entrants regarding the Promotion;
- Facilitating any resulting motorcycle purchase; and
- Related marketing purposes where permitted by law and consent has been obtained.

Personal information will be handled in accordance with the Promoter's applicable Privacy Policy.

17. Limitation of Liability

To the fullest extent permitted by law, the Promoter shall not be liable for:

- Lost, delayed, corrupted or incomplete entries;
- Technical malfunctions or system failures;
- Communications failures;
- Delays relating to motorcycle production, importation or delivery;
- Costs incurred by entrants in connection with participation in the Promotion; or
- Circumstances outside the Promoter's reasonable control.

Nothing in these Terms and Conditions excludes, restricts or modifies any rights or remedies available under applicable Australian Consumer Law or New Zealand consumer protection legislation.

18. Modification or Cancellation

The Promoter reserves the right to modify, suspend or cancel the Promotion at any time where reasonably necessary due to circumstances beyond its control, including but not limited to manufacturing, supply chain, regulatory or operational issues.

Where required by law, the Promoter will provide notice of any material changes.

19. Governing Law

Entrants residing in Australia acknowledge that these Terms and Conditions are governed by the laws applicable within Australia.

Entrants residing in New Zealand acknowledge that these Terms and Conditions are governed by the laws applicable within New Zealand.

Any disputes arising from this Promotion will be subject to the jurisdiction of the courts of the entrant's country of residence.
